## **TERMS AND CONDITIONS**

1. Participants must be fit enough to cover the distance of the Chicago Marathon (26.2 miles). By signing the pledge form you are confirming that to the best of your knowledge, your general state of health is good and that you take full responsibility for yourself.
2. Participants participate at their own risk and agree to indemnify the Rainforest Foundation, or its employees against claims for loss or damage to personal property, personal injury (or death), and any claim arising from the entrants own actions
3. Participants are responsible for their own training.
4. The Rainforest Foundation will provide advice on fundraising wherever possible.
5. Participants must seek and obtain permission from the Rainforest Foundation to use the name and logo, especially for any use other than obtaining direct personal sponsorship from individuals for the event.
6. Participants will not knowingly bring the name or logo of the Rainforest Foundation into disrepute.
7. Entries will only be accepted upon receipt of a non-refundable £260 deposit (£150 part payment for transport & accommodation; £50 for administration and £60 for race entry). A further second payment of £795 for transportation and accommodation (refundable in accordance with para.11) must be received before 8<sup>th</sup> August 2004. The deposit and second payment (£1,055) will be refunded *only* upon receipt of at least the minimum agreed sponsorship (£2,000).
8. Accommodation is allocated by Sports Tours International on a twin-share basis. Single rooms are available – a supplementary charge will apply, payable by the participant.
9. Participants undertake the Chicago Marathon to raise a minimum of £2,000 for the Rainforest Foundation. The £2,000, together with any additional sponsorship monies raised in excess of £2,000, must be paid to the Rainforest Foundation within 45 days after the event.
10. All payments (deposit & donations) must be in the form of a cheque or postal order made payable to “The Rainforest Foundation”.
11. In the event that participants are unable to participate in the race, the accommodation and transportation (£945) will be reimbursed in accordance with the Terms and Conditions of Sports Tours International Ltd.
12. Participants must have suitable travel insurance, including cancellation cover before a booking can be made. Proof of this must be provided. Alternatively, insurance can be booked through Sports Tours International Ltd (£38 for up to 5 days).
13. Registration, transportation, accommodation and insurance will be booked through Sports Tours International Ltd (ATOL number 2711), and their booking Terms and Conditions apply.
